**Minutes**

Commissioner Rolfes motioned to approve the January 27, 2020 regular meeting minutes; Commissioner Morales seconded the motion. All voted aye.

**Budget and Finance – Bill Rolfes**

Rolfes motioned to approve the January 2020 financial statements. Morales seconded the motion, all voted aye.

**Special Events – Bill Rolfes**

Rolfes reported the city 30-year anniversary celebration is scheduled for May 9, 2020 and will take place at the fieldhouse at Creasey Mahan.

**Drainage- Todd Hall**

Hall stated he received a request from a resident to check on a drainage issue on Valley Drive. He will report back to the commission after looking at it.

**Stormwater Mitigation – Todd Hall**

Hall reported the city has spent \$2800 of the \$7500 set aside in the budget to set up the city's own Stormwater mitigation program. Hall stated the estimated cost moving forward will be \$5000-\$7000 per year which could be reduced if a city employee takes over some of the reporting tasks. Hall motioned pursuant to section 21 of the Interlocal Cooperation Agreement relating to co-permitting under the Clean Water Act, between the City of Goshen and Oldham County to hereby give Oldham County 30- day notice of City of Goshen's decision to cancel said interlocal cooperation agreement and then pursue its own permit. Thacker seconded the motion. Hall, Thacker, Dearmond and Rolfes voted aye. Morales was opposed.

Dearmond stated he's still waiting on another bid on the electrical work at the front entrances.
