

CITY OF GOSHEN COMMISSION SPECIAL MEETING MINUTES
November 7, 2022

The special meeting of the City of Goshen Commission was called to order at 7:00 PM by Mayor Bobby Thacker at North Oldham Fire Station, 1660 Hwy 1793, Goshen, KY with the following members present:

Commissioner Todd Hall was absent.

Tim Dues, vice president of EZ Construction, and Steve Emly, OHM Advisors, were present.

Mayor Thacker stated the purpose of the special meeting is to address residents' concerns with the drainage project on Harmony Landing Road.

The following residents/ homeowners voiced concerns regarding the aesthetics and safety of the rock ditch that has been installed along Harmony Landing Road, in front of four homes.

Steve Emly stated his firm was never asked to do a design. The scope of work had already been determined when he was asked to do a bid package. The goal was to slow the water down and keep water from crossing Harmony Landing Road. Steve stated he did have conversations with Commissioner Hall regarding the aesthetics and maintenance of a rock ditch.

Tim Dues stated other options could be to pipe the ditch but it would be shallow and catch basins would need to be added. Option 2- would be a concrete ditch or grass swale.

Thacker stated the cosmetics and safety of the ditch has to be addressed. Thacker motioned to name Doug Morales as committee chair of drainage until the end of the year. Rolfes seconded the motion. Thacker, Rolfes and Mangan voted aye. Morales abstained.

Morales motioned to contract with Advisor's OHM for a drainage study and drawings. Motion died for lack of a second. Emly stated OHM already has a contract with the city and could come up with a solution pretty quickly.

Morales motioned to stop work on Springmeadow Park. Thacker called for a point of order as only items on the agenda can be discussed in a special meeting.

Rolfes motioned to adjourn. Mangan seconded the motion. All voted aye. Meeting adjourned at 8:24pm.
