**Pledge of Allegiance**

**Welcome** – Bobby Thacker called the meeting to order at 7:00 p.m. Commissioners Hall and Rolfes were absent.

**Minutes of September 19, 2022**, Jeff Mangan made a motion to approve the minutes as presented Doug Morales seconded the motion. All voted unanimously to approve them.

**Special Guest** – Daniel Fendley, candidate for district court judge.

**Budget Committee- Bobby Thacker**

Bobby Thacker motioned to approve the September financial reports. Doug Morales seconded the motion. All voted to approve.

**Newsletter – Bobby Thacker**

Bobby Thacker reported a newsletter went out the last week of September.

**Drainage/ Stormwater – Bobby Thacker**

Thacker stated the drainage work on Harmony Landing Road should be wrapping up in a week or so.

**Architectural Control – Doug Morales**

Tom Johnson, 1023 Harmony Landing Road has submitted an architectural control form for a driveway extension and a spilt rail fence. Thacker motioned to approve the driveway extension, Morales seconded the motion. Thacker and Morales voted aye. Mangan abstained. Motion

approved. No action was taken on the fence request. The homeowner decided to hold off on the fence at this time.

#### **Street and Public Works – Doug Morales**

Morales reported EZ Construction will patch two small potholes on Rollingwood and Club when they have the asphalt truck in the area.

The broken light pole at Hollendale and Harmony Lane has been reported to LG&E.

#### **Ordinance Enforcement – Jeff Mangan**

Mangan stated the clerk spoke with Jim Urban, Oldham County Planning and Zoning, regarding short term rentals within the city. Planning and Zoning can deny license for short term rentals at the city's request as they are considered commercial businesses. Thacker motioned to approve a letter to OC P&Z requesting denial of short term rental licenses. Mangan seconded the motion. All voted aye.

#### **Public Protection/ Health & Safety – Jeff Mangan**

Mangan reported the city will have a deputy patrolling and passing out candy on Halloween night.

#### **Parks – Bobby Thacker**

Thacker stated work on the sports courts will begin when the contractor finishes the Harmony Landing Rd project.

WiFi install is proceeding at the park. Contractor needs to hand dig part of the trench.

#### **Sanitation – Bobby Thacker**

No report.

#### **Beautification – Bobby Thacker**

Thacker reported he has shut down the water fountain at the park for the winter. Christmas lights will be turned on Thanksgiving night.

#### **Special Events – Bobby Thacker**

Thacker reported Santa and the carriage have been reserved for December 17<sup>th</sup>.

The city will hold a decorating contest again this year.

The city will hold a toy drive for eastern Kentucky flood victims. The clerk will reserve a rental truck and arrange for drop off locations.

#### **Administrative Issues**

Thacker motioned to approve Creasey Mahan Nature Preserve's grant request of \$1000 for the Nature of Christmas in Goshen. Mangan seconded the motion. Thacker and Mangan voted aye. Morales abstained. Motion approved.

Thacker motioned to change the December 19<sup>th</sup> commission meeting to December 12<sup>th</sup>. Mangan seconded the motion, all voted aye.
